Who we are



We are the Royal Enfield Club Netherlands, an association for enthusiasts of Royal Enfield motorcycles and you can contact us via our website:

Terms used:

- website: the website including Facebook Group and other online parts, agenda and the members-only section
- Facebook Group: part of the website where members can post messages
- Members-only: the part of the website that is only accessible to members using login details
- user, visitor, you; everyone who uses the website
- member, members: visitors to the website who are members of the club
- club, we: Royal Enfield Club Netherlands or RECN for short

What personal data we collect and why.

We only collect data to provide our services or to contact the website user if he or she has requested it, e.g. via a contact form or a registration form. The user of this website provides the data voluntarily and the data is used with permission.

The requested privacy-sensitive data are: the name and address details and the IP address (the IP address is the number with which you can be recognized on the internet; every PC, tablet or smartphone that is connected to the internet has such a unique number). This data is used, among other things, to check the legality and to carry out the activities of the club. The data will only be used for the functioning of the club and will not be given to third parties.

By becoming a member of the club, you also agree that name and address details will be published in the club magazine Bulletin after becoming a member and with subsequent changes. This is done to inform all members of the club.

Forms

Data obtained via one of the forms on the website will only be used to provide the requested service.

The data will be kept for as long as it is necessary to provide the requested service.

Cookies

Of course we love cookies, especially stroopwafels. However, this concerns so-called cookies, which are placed on visitors' PCs to record information, including for the functioning of our website.



When visitors visit the public website, they must accept this Privacy Statement and allow the use of cookies. By accepting this, cookies are placed for confirmation. These cookies do not contain any personal information.

Even when visitors log in to the members-only part of the website, we only place cookies without personal data. The website is accessed by general login details.

We do nothing further with the data in those cookies. They serve solely to make the website work and the user experience as good as possible.

The visitor can delete all cookies at any time via his or her own browser. Access to the website will still be possible, but the user experience will be like the first time the website was visited. So you may have to accept the Privacy Statement again, log in, etc.

Added content from other websites

Parts of the website may contain embedded data (e.g. videos, images, articles, maps, etc.) from other websites, which behave exactly as if the visitor were visiting that other website.

Although we do not exchange data with those other websites, they may collect data, place cookies, add third party information, and record your interactions with that embedded information. Personal data can be stored if you have an account and are logged in to that other website at the same time.

With whom do we share your data and how long do we keep it?

We do not share data with third parties.

The data provided by users will be retained until the requested service has been provided and the data is no longer necessary for the club's business operations.

What rights do you have over your own data?

No personal information is requested on the website. If you do not want any data in the membership list, your membership will be terminated.

Where does your data go?

Data entered, provided via a contact form or registration form, will only be used to send an email to the club. Once the contact or registration has been completed, the emails will be deleted if they are no longer needed for administration.

Security

The data is sent via an SSL secured website. SSL stands for **Secure Sockets Layer** . In short, it is the standard technology to keep an internet connection secure and to protect (sensitive) data exchange between two systems, to prevent criminals or other malicious parties from reading or modifying this information.

The database in which data is stored is also protected against unauthorized use.

The website uses a so-called recaptcha function from Google. This prevents misuse of the website by automated robots.
